FREQUENTLY ASKED QUESTIONS ACET TRAINING



Q: When is the next training session?

A: The next trainings are:

- Fri Oct 4th, Sat 5th, and Sun 6th (9am -5pm)
- Fri Dec 13th, Sat 14th, and Sun 15th (9am-5pm)

The class is limited to 20 fellow EVS Techs and the last day to sign up for the class is Monday, September 30. Signing up sooner is better.

Q: Where is it? How do I get there?

A: The October ACET training will be at the SEIU Union Building in Kent.

Q: How long is the training?

A: The training is 3-days, 8 hours a day (24 hours).

Q: Will I get a pay increase for completing the training?

A: Yes. Check with your union contact or your supervisor to find out the details about certificate pay and the amount.

Q: How much is the stipend?

A: The stipend for the 3-day training is \$100. You will receive this stipend to pay for your transportation, parking, and lunch (\$33.33/day).

Q: What happens on each day of the training?

A:

- Day 1 will be in-person classes with both an instructor and tutor (8 hours)
- Day 2 will continue with in-person classes with an instructor and tutor (4 hours) and then working with your mentor on-site (4 hours)
- Day 3 will begin with Final Exam Review (4 hours), then the Certification exam (4 hours)

Q: How do I get this time off?

A: Please check with your supervisor to help you arrange and to approve your time off.

Q: Will there be a tutor and/or English language help available at the training?

A: Yes! We will have a tutor/English language instructor helping at the 3-day training - right there in the classroom with you. If you have a question, you can ask them right then and there.

Q: Will I need a laptop?

A: Yes. We will provide laptops for the training.

Q: How long does the ACET training remain valid?

A: The ACET certificate remains valid for 3 years

Q: What if I already did a training like this?

A: If you did the CHEST training already, then you do not need to do the 3-day ACET training. You can do the special 1-day training for EVS Techs who have already done CHEST training – the ACET Bridge Course.
